**CLARIFICATIONS: NATIONAL TRIAL ADVOCACY & JUDGMENT WRITING  
COMPETITION 2022**

1. Will the participants be allowed to bring the accused as a witness by an application of Section 313 of the CrPC ?

**CLARIFICATION:** No, the participants will not be permitted to bring the accused as witness by an application of Section 313 of the Code of Criminal Procedure.

2. Whether the participants are permitted to use extra evidences (doctor report and medical report) ?

**CLARIFICATION:** No, the participants are not permitted to use extra evidences except for the documents that form a part of the chargesheet.

3. Whether the participants are allowed to bring their own witnesses?

**CLARIFICATION:** No, the witnesses will be provided by the Host College.

4. What is the Doctor's name - Nitin or Nilesh?

**CLARIFICATION:** The Doctor's name should be read as Dr. Nilesh Chikalkar.

5. Whether the case is only against Karan Jadhav or is it against Karan Jadhav & Anr?

**CLARIFICATION:** No Clarifications needed, *kindly refer to the FIR.*

6. How much Abrocitinb was found in the body of the deceased?

**CLARIFICATION:** No Clarification needed.

7. What about Varsha's whereabouts?

**CLARIFICATION:** No Clarification needed.

8. Where does Karan Jadhav work currently?

**CLARIFICATION:** No Clarification needed.

9. What is Karan Jadhav's age?

**CLARIFICATION:** Karan Jadhav's age is 28 years old.

10. When was the Charge Sheet for the case filed?

**CLARIFICATION:** The Charge Sheet was filed on 2<sup>nd</sup> May, 2021.

11. What is the session case number?

**CLARIFICATION:** The Session Case Number is S.C. No. 131/2021.

12. What property does Karan Jadhav have under his possession?

**CLARIFICATION:** No Clarification needed.

13. Whether the participants are allowed to add more provisions/charges than given in the FIR?

**CLARIFICATION:** Yes, the participants are allowed to add more charges in the FIR.

14. What are the areas of law that one would require to have prior knowledge of for the Judgement Writing Competition?

**CLARIFICATION:** No Clarification needed.

15. FIR, Page No. 2, Point 6, "60 m from Vile Parle Police Station". Is it 60 m or 600 m ?

**CLARIFICATION:** No Clarification needed.

16. Rule 10.2.4 states that each speaker shall have to conduct Examination-in-chief and cross examination of at least one witness in each round. Whether is permitted if One Speaker conducts examination-in-chief of all three witnesses while the other speaker conducts cross examination of all three witnesses of the other side.

**CLARIFICATION:** No Clarification needed.

17. Will the participants have access to the database while appearing in the Judgement Writing Competition? If not, how early would the proposition for the Judgement Writing Competition be released?

**CLARIFICATION:** No, the participants will not have access to the database while appearing for the Judgement Writing Competition. The Judgment Writing Competition will be based on the Semi Final Round and the Judgment Writing Competition will take place immediately after the Semi Final Round on 9<sup>th</sup> October, 2022.

18. What is the Judgement Writing Competitions time duration?

**CLARIFICATION:** The time duration for the Judgment Writing Competition is One hour.

19. What is the format for the Judgement Writing Competition?

**CLARIFICATION:** *Kindly refer to the Rules for the Judgment Writing Competition on Page No.9 of the Rules and Regulation along with Rule 1.3.2.*

20. Whether the Judgement Writing Competition is dependent upon the qualifications of the teams for the further rounds, or can all researchers from the 24 teams take part in it?

**CLARIFICATION:** *Kindly refer to Rule 1.3.2.* It is compulsory for one Researcher from each team will have to participate in the Judgment Writing Competition on 9<sup>th</sup> October, 2022.

21. Under annexure-I, the email provided, it is evident that there is a distinction in the clarity of the To-address and date compared to the rest of the contents in the mail. Is that something that can be contested during the trial or the submissions provided under the annexure are not to be questioned?

22. The date of submission of the WhatsApp chats by DW1 has not been provided. It is a requirement for submission of the certificate under Section 65B of the Indian Evidence Act.
