THEME OF THE EVENT

The XVII Amity Moot Court Competition, 2026 will explore the dynamic relationship between constitutional principles and contemporary legal issues. Participants will engage in a thorough examination of constitutional interpretation, emphasizing how foundational legal concepts adapt to evolving societal challenges. Through rigorous debate and analysis, competitors will navigate the intersection of historical context, judicial precedent, and modern-day legal dilemmas, promoting a deeper understanding of the constitution's role in safeguarding justice and individual rights.

GENERAL RULES

1. Qualified teams are requested to submit 10 hard copies (Petitioner-5 and Respondent-5) at the time of formal registration at the venue on 23rd February 2026
2. The language to be used during the rounds is English.
3. The Competition shall consist of the following rounds:
 - Preliminary Round I and Preliminary Round II (Online)
 - Quarter finals
 - Semi finals
 - Finals
4. During each of the above-mentioned rounds, the order in which the teams shall present their arguments is as follows:
 - Petitioner Speaker 1
 - Petitioner Speaker 2
 - Respondent Speaker 1
 - Respondent Speaker 2
 - Rebuttal: Petitioner-Any one of the two Speakers
 - Sur-rebuttal: Respondent-Any one of the two Speakers

WHO CAN PARTICIPATE?

- The competition is open to all students, enrolled bona fide, on a regular basis in an undergraduate law course (3 years/ 5 years) conducted by any recognized College/Institution/University.
- A recognized College/Institution/ University may send more than one teams to the competition.
- Each team shall comprise a minimum of two members and a maximum of three members. In a team comprising of two members, both members shall be designated as speakers. In a team comprising three members, two members shall be designated as speakers and the third member shall be designated as a researcher.
- Teams shall not disclose their identity or that of their institution. However, the speakers can disclose their names only to the bench during the oral arguments at the discretion of the judges.

METHOD OF REGISTRATION

- Each team must register by filling up the registration form available at <https://www.amity.edu/lucknow/paymentgateway/mootcourt2026/> and paying the registration fee as provided. Each team shall complete such registration by 31st January 2026. (23:59:59 Hours IST).
- Registration fee: Rs. 3,000/- (Rupees Three Thousand Only) + GST.
- Registration fee will be non-refundable in case of non-participation after registration.
- The reporting time is 10:00 Hours IST on 23rd February 2026 at the registration desk of the competition venue and submission of hard copy.
- Accommodation will not be provided by the college; however, the committee will offer assistance and guidance regarding accommodation arrangements.

NOTE: Intake/use/mere possession of any prohibited substances (eg. cigarette/alcohol /narcotic substance/any sharp object) is strictly prohibited during the stay throughout the competition, non-compliance of which may lead to immediate disqualification.
