## Kindly provide clarifications on the below mentioned queries:

**1.** Is Bunkoostan a monist or a dualist country?

## **CLARIFICATION:** Monist.

- 2. Is Sundarland a monist or a dualist country? <u>CLARIFICATION</u>: Monist.
- 3. Are the two countries party to the Vienna Convention on Diplomatic Relations? <u>CLARIFICATION</u>: The countries are party to only the treaties mentioned in Note (a) of the Proposition.
- **4.** Are both states party to the Optional Protocol of VCCR concerning the compulsory settlement of dispute?

<u>CLARIFICATION</u>: The countries are party to only the treaties mentioned in Note (a) of the Proposition.

- Which country's laws are pari materia to India?
   <u>CLARIFICATION</u>: No country's laws are pari materia to India.
- 6. Is there a prescribed referencing style to be followed? <u>CLARIFICATION</u>: Yes, please refer to the <u>20<sup>th</sup> Harvard Bluebook edition</u> for referencing style to be followed. The same shall be attached in the attachments area for kind reference.



- 7. Is illicit trafficking of drugs to nations where it is not legalised a crime in Bunkoostan?
   <u>CLARIFICATION</u>: The law in Bunkoostan is silent on this aspect.
- **8.** Were the accused detainees made aware of the charges and were they present at their trial?

**<u>CLARIFICATION</u>**: It is not known since the trial was conducted behind closed doors.

- 9. Is the legalisation of drugs regulated by certain laws in Bunkoostan? <u>CLARIFICATION</u>: As made clear by Para 4 of the Proposition, only the medical and recreational use of cannabis has been legalised in Bunkoostan. All other contrabands continue to stay illegal. The production, sale and manufacture of cannabis is regulated by the Government of Bunkoostan.
- 10. What were the countries in agreement with Bunkoostan for transportation of Cannabis?

   CLARIFICATION: There were no agreements for transportation of cannabis.
- 11. What kind of contract did SafestXpress have with the government of Bunkoostan?
  <u>CLARIFICATION</u>: SafestXpress was contracted by the Government of Bunkoostan.
- 12. The facts of the case state that "However, being a landlocked nation, a lot of this cannabis had to be transported through countries where cannabis was illegal". Did Bunkoostan transport these cannabis through proper channels by notifying the other countries (countries where cannabis was illegal i.e. Sundarland, Annapirgo..) along with the correct licenses and authorizations as required by the Drug Conventions? Or is this fact left ambiguous on purpose?

<u>CLARIFICATION</u>: Participants are expected to reasonably interpret the facts provided in the Proposition.

**13.** What is the procedure by which Bunkoostan legally exports drugs (to be specific; cannabis) to other countries?

**CLARIFICATION:** Refer to answers in Q. 7 and 12.

**14.** What is the procedure by which Bunkoostan transports commodities other than drugs to other countries?

<u>CLARIFICATION</u>: Trade Agreements and/or reciprocal arrangements with other nations.

15. Does Safest XPress have other functions besides their contractual obligation to Bunkoostan?


### **<u>CLARIFICATION</u>**: It is not known.
