ABOUT NUJS

The West Bengal National University of Juridical Sciences (NUJS) was established under the WBNUJS Act, 1999 (West Bengal Act IX of 1999) adopted by the West Bengal Legislature in July, 1999. The University was notified under Clause (f) of Section 2 of the UGC Act, 1956 in August 2004 and has been granted permanent affiliation by the Bar Council of India in July 2005. Initially, classes, which started in 2000, were held at Aranya Bhavan, where the Environment Ministry of the Government of West Bengal is located, and the first batches of students started living in government flats. On 28 October 2002, the university's present-day permanent campus was inaugurated by the then Chief Justice of India, B. N. Kirpal. NUJS has been awarded A+ accreditation by the National Assessment and Accreditation Council in 2024.

ELIGIBILITY AND TEAM COMPOSITION

- The Competition is open to all students, enrolled bona fide at the time of the competition on a regular basis in an undergraduate LL.B. degree programme (either 3 years LL.B. or 5 years LL.B.) or its equivalent conducted by any recognized Institution/College/University in India. Students enrolled in postgraduate or diploma programmes are not eligible to participate.
- Each Team shall comprise a minimum of 2 (two) and maximum 3 (three) members. In case of a three-member team, two members of the Team shall be designated as Speakers and the third member shall be designated as the Researcher. In case of a two-member team, both members shall be designated as Orators.
- Any additional member or Team Coach accompanying a Team shall not be recognized and will not be entitled to a certificate for the Competition.



GENERAL INFORMATION

- The Competition shall be conducted in accordance with the rules mentioned in the rule book. Participants are required to comply with the rules and procedures prescribed therein.
- The Organizing Committee (“OC”) shall function as the point of contact, and any changes in the Rules of the Competition shall be notified by email to all participating teams.
- The official email for all correspondence with respect to the Competition is sitcmoot@nujs.edu.

REGISTRATION

- In this edition of the competition, all the teams desirous of participating in the competition should register themselves by completing the payment and filling out this form, by 30th September 2025. Following which the teams will be assigned their team codes, which would be required to submit the memos.
- In case a team finishes their registration before 30th August 2025, their registration shall be considered as early bird registration.

REGISTRATION FEE

- The registration fee per team for the memo qualifier round is INR 4,500 for early bird registrations and INR 6,000 for regular registrations.
- The top 32 teams will be required to make an additional payment of INR 6,000 by 4th November 2025 for registration in the speaking rounds (this would include accommodations and local transportation from the University to the place of accommodation for the days of the event).

- Teams that have registered for the competition may withdraw from the competition after informing the OC of such withdrawal on or before 10th September 2025. If a team intimates a notice of withdrawal on or before 10th September 2025, then the registration fee paid, if any, will be refunded to the Team, after deducting transaction costs. In case a Team fails to intimate a notice of withdrawal within the stipulated time, such Team shall not be entitled to any refund.

ANONYMITY OF TEAMS

- Teams shall not reveal their Identity in any form, except by means of the Team Code assigned to them in accordance with Rule 3.4 of the Rules of the Competition.
- Teams shall not, in any way, reveal their Identity in the Written Submissions or in the course of the Oral Pleading Session.
- Any material, including the Compendium, books, bare acts, or any other reference material, carried during the Oral Pleading Session, whether presented to the Bench or not subject to Rule 8.8, shall not reveal the Team's Identity and shall be devoid of any identification marks/ seal of the Team or the Institution/College/University represented. If anything on the material carried during the Oral Pleading Session reveals the Team's Identity, the Team shall render the same unrecognisable to the satisfaction of the OC prior to joining the Oral Pleading Session.
- Any violation of Rules 4.2 or 4.3 of the Rules of the Competition may attract disqualification of the Team from the Competition or any other penalty as determined by the OC. The decision of the OC in this regard shall be final and binding.

CLARIFICATIONS TO MOOT PROBLEM

- Teams may seek Clarifications via e-mail to sitcmoot@nujs.edu, latest by 20th August 2025 (11:59 P.M. IST).
- All Clarifications, if any, shall be sent out to all teams via email by 30th August 2025. This date may be subject to change.

STRUCTURE OF COMPETITION

- The competition will have two parts, the memo qualifier round and the speaking rounds.
- Top 32 submissions sent for the memo qualifier round will qualify for the speaking rounds to be held at the NUJS campus in November 2025.
- The Opening Ceremony and Orientation of Participants will be held on 14th November, 2025.
- Preliminary Rounds and Quarter Final Rounds will be conducted on 15th November, 2025, and Semi Final Rounds and the Final Round on 16th November, 2025.
- The Competition shall consist of the following Oral Pleading Sessions:
 - a. The Preliminary Rounds 1;
 - b. The Preliminary Rounds 2;
 - c. The Quarter Final Rounds;
 - d. The Semi-Final Rounds; and
 - e. The Final Round.

- Teams shall be responsible for their transportation to and from the airport / railway station / bus station to the accommodation. This will be coordinated by the members of the OC.

MISCELLANEOUS

- The OC reserves the right to modify any of the Rules of the Competition. The OC shall communicate any changes made in the Rules of the Competition to the Teams.
- The OC reserves the right to take decisions on any matter not mentioned in the Rules of the Competition. Any such decision taken by the OC shall be final and binding.
- The OC reserves the right to interpret any of the Rules of the Competition. Such interpretation shall be final and binding.
- If any one member of a team is notified or informed of any detail or information concerning the Competition, it shall be deemed as if the said team as a whole has been duly notified or informed.
- If a Team is of the view that the Rules of the Competition have been violated at any stage of the Competition, the Team shall, within half an hour after the completion of the round in which the alleged violation has occurred, register a complaint with the Office Bearers of the Competition.
